Pursuant to SEBI Circular No. SEBI/HO/DDHS/CIR/P/2018/144 dated November 26, 2018, SEBI/HO/DDHS/P/CIR/2021/613 dated August 10, 2021 (updated as of April 13, 2022) and SEBI Master Circular No. SEBI/HO/DDHS/PoD1/P/CIR/2023/119 dated August 10, 2021 (updated as on July 07, 2023), M/s Kamarajar Port Limited (KPL) was a large corporate (LC) as the outstanding borrowings was more than Rs 100 Cr and the required disclosures were made accordingly.
